Nothing in this agreement shall establish an employment relationship or any other labour relationship between me and Redpool India Private Limited and nothing shall establish my Independent distributor's position as procurer, broker, commercial agent, contracting representative or other representative of REDPOOL India Pvt Itd. When purchasing and selling the REDPOOL products, the independent distributor shall act as an independent vendor, acting In his/her own name, at his/her own responsibility and for his/her own account.

3. Relation between Redpool India Pvt Itd and the distributor and all his/ her activities hereunder shall be governed, in addition to this agreement by the Redpool sales and marketing Plan and the distributor's policies and procedures which may be in force from time to time.
